Special Waste Collection

A special waste collection is scheduled for Monday, September 22nd, 2025 and Thursday, September 25th, 2025. Waste collection is expected to begin at approximately 7:00 am. Bulky items (including refrigerators/freezers) will not be picked up during these waste collection days. There will be leniency on quantity of bags being picked up. Please refer to the "disposal of food waste" section on how to manage the spoiled food waste appropriately.

Valley Waste Management Green Compost Bin

Annapolis County is partnering with Valley Waste Management to deliver new green compost bins to residents who may have lost them because of the West Dalhousie Wildfire. Bins will be delivered on Friday, September 19th, 2025 to residents who may be missing a bin. Residents are limited to one bin per household. We encourage all residents to utilize these green compost bins to assist in the disposal of food waste.

Disposal of Food Waste

- Re-freeze food before handling. This will cut down on the odor.
- After the food is frozen, remove waste from packaging and put into the compost bin. Plastic and Styrofoam food packaging should not be placed in the compost bin; they need to be disposed of separately.
- If the compost bin is full, additional food waste should be put into a clear plastic bag. Bags should be less than 30 pounds / 14 KG.
- If the food item is unable to be removed from its packaging, the packaging and food waste should be placed in a clear plastic bag. If the bag is heavy, it should be double bagged.
- Fluids (such as milk, juice, soda) should be drained before disposal.
- Empty containers should be recycled, disposed of as appropriate.
- There will be leniency on waste bag limits for impacted residents.
- This special pickup will not be picking up appliances or bulky waste. Additional plans are being put into place to assist with the disposal of bulky items moving forward.

- DO NOT tape up the fridge / freezer with food inside and put it on the curb. It is illegal to dispose of appliances in this manner.
- DO NOT use black bags to dispose of food waste.

Disposal of Fridges and Freezers

Residents who need to dispose of their refrigerators and freezers are asked to:

- Call the Annapolis County Public Information Hotline (1-833-806-1515)
 - o Report your address, phone number, and how many fridges and freezers will need to be picked up.
- Remove the contents of the fridge and freezer and dispose of it properly. (See Disposal of Food Waste)
- Move the fridges and freezers to the curb.
- A pickup of the appliance will begin on Tuesday, September 23rd, 2025.

As a high volume of requests for this service is expected, please be patient as we process requests.

Additional Garbage

Residents wishing to self-haul garbage exceeding curbside limits may take their waste to the Valley Waste Management – Lawrencetown Transfer Center (343 Elliott Rd, Lawrencetown, NS; 877-927-8300).

Burnt materials are acceptable at the Lawrencetown Transfer facility along with small amounts of mixed in ash. They will be transported to a second-generation landfill (Kaizer Meadow landfill).

If you need to dispose of truckloads of ash, then it will need to go directly to Kaizer Meadow Landfill

Pressure treated wood and creosote wood must be brought to Lawrencetown or a second-generation landfill as it is banned from construction and demolition disposal sites.

Please note that drop-off of construction and demolition debris is free for evacuees at either Valley Waste site until October 20th, 2025. The other sites may charge a disposal fee. Residents needing additional assistance with debris removal will be given additional consideration.
